# Agroforestry sector in the EU: Towards novel policies and financing frameworks

Barcelona, June 28<sup>th</sup> 2023

16:30 - 18:00 CET

## Background and content

With the European Green Deal's increasing ambition to address climate change and environmental degradation, there is a need for policy initiatives and sustainable practices that can transform the EU into a modern, resource-efficient, and competitive economy. Agroforestry, as a multifunctional system, holds great potential for driving this transition by offering environmental, economic, and social benefits.

Working towards this ambition, EMEA is contributing to the ReForest project, funded by Horizon Europe. The project aims to promote the adoption of agroforestry systems among farmers by facilitating effective and sustainable financing at both national and EU levels. Our current work focuses on examining the existing regulations, funding schemes, and policy frameworks applicable to agroforestry in Europe. We aim to lay the groundwork for the development of innovative financial instruments and policy recommendations, drawing on insights from living labs, as well as active engagement with policymakers and financial industry stakeholders. The project also aims to place the economic value of agroforestry ecosystem services and their environmental and socio-economic benefits at the core of financial considerations.

Recognising that similar goals are shared by many other projects and initiatives, EMEA is organizing a policy session titled "**Agroforestry sector in the EU: Towards novel policies and financing frameworks**" within the ReForest project activities. The objective of this session is to bring together experts in the field and provide them with a platform to share the latest developments and knowledge regarding finance and policies relevant to the agroforestry sector in the EU. The policy session will specifically address topics such as the current regulatory

and policy framework for agroforestry, financial mechanisms applicable to agroforestry systems, carbon markets, and anticipated changes, as well as recommendations for innovative policies and financing frameworks in the agroforestry sector within the EU.

The event will take place at EMEA on June 28<sup>th</sup>, 2023 (16:30-18:00) in a hybrid format and will bring together representatives of relevant and well-known research organisations working on agroforestry in Europe. Participants have the option for either physical presence or virtual participation.

- 6. What are the expected changes to come and recommendations towards novel policies and financing frameworks in the agroforestry sector in the EU?
